The undersigned, personally and in behalf of the undersigned's heirs, personal representatives and assigns, for and in consideration of Parker Ranch (including its personnel, Trustees, and agents) permitting and allowing the use of the designated facilities agrees to indemnify and save harmless Parker Ranch Inc. against any and all loss, liability, demands, claims, suits, actions or proceedings of every name, character and description which may be suffered or incurred by or brought against Parker Ranch for or an account of any injuries or damages to any person or property received or sustained by any person, directly or indirectly, by or in consequence of the use of the facilities by the undersigned individual. I, the undersigned, understand that HAWAII LAW (Chapter 663B, HRS) limits the civil liability of persons offering rodeo type activities. I understand that there are inherent risks of injury, including death, when participating with and riding horses and/or bulls and being around other livestock, such as cattle/ which risks include, but are not limited to injury and death to persons on or around it, hazards of such as surface and subsurface conditions. Collisions with other objects and animals, the unpredictability of a horse or any animal reaction to such things as sound, sudden movement, unfamiliar objects, persons, or other animals and potential negligence of another participant, such as failing to maintain control over their horse or not acting within their ability, Knowing and understanding the risks of riding and participating with horse and/or bull riding, including injury and death to my person and damage to my person property, I expressly chose to assume these risks. The undersigned agrees that this instrument is a legal contract and is binding on his/her heirs and assigns. I also abide by all rules and regulations set forth by HHSRA and Parker Ranch. I have read and understand all the above. The undersigned also acknowledges that Parker Ranch is NOT the sponsor of this event and that the HAWAII HIGH SCHOOL RODEO ASSOCIATION is the sponsor.

We, the parent/guardian of _____, give the: NORTH HAWAII COMMUNITY HOSPITAL and the Physicians on the Medical Staff of the Hospital permission to administer NECESSARY EMERGENCY treatment for injuries he or she may incur while participating in the Hawaii District Rodeo of the Hawaii High School Rodeo Association. We understand that each contestant must be and is covered by medical insurance. We hereby release the NORTH HAWAII COMMUNITY HOSPITAL, Physicians on the Medical Staff, as well as Parker Ranch Inc., the HHSRA and its Directors, the National Director, the Rodeo Sponsors, their heirs and assigns, from any and all claims, responsibilities and liabilities, except for negligence, which the undersigned may have as a result of his or her participation at this rodeo and its related facilities on **May 9, 10, 11, 12 2019.**

CHECK-IN

Shooting contestants must check in on *Thursday May 9th, 2019 at 9:00am at Parker Ranch Headquarters*. Back numbers and contestant packets will be distributed to all shooting contestants at this time. Dress code, must wear long pants and covered shoes. Immediately following check-in, contestants will be escorted to the Parker Ranch Shooting Range where the .22 Long Rifle competition will be held at 10:00am

ENTRY BLANK

On your entry blank, check the shooting event as if entering a regular rodeo event. If you are ONLY shooting, DO NOT pay the arena fee. A range fee has been added to your event fee. You must pay the office fee. Should you have questions or need clarification, contact State Secretary DeeDee Bertelmann as noted above.

SHOOTING

Shooting contestants are responsible for his/her own equipment, including: .22 rifle, ammunition, safety gear, eye, and ear protection. This is mandatory. Please contact Shooting Event Coordinator Richard Kaniho via the contact information above, with any questions or concerns you may have.

MANDATORY CERTIFICATION

For liability reasons, in order to enter the shooting event at the Junior State Finals, you must have completed an NRA First Step Certification course or possess a special certification from the Hawaii State Shooting coordinator, DeLance Wiegele. Proof of certification is required.

If you plan on traveling to Nationals, you must be present at the HHSRA Junior Finals Awards Banquet on *Sunday May 12th, 2019 at Pukalani Stables, Kamuela, Hawai'i*. National forms must be completed at this time and both parents must be present for notarization and signing of forms for contestant to travel. IF for some reason a parent is not able to attend please contact DeeDee ASAP to make arrangements.

CONTESTANT BACK NUMBERS MANDATORY FOR ADMISSION, only 1 guest per contestant.

SUNDAY MAY 12, 2019 9:00 AM - AUCTION / AWARDS to follow immediately after / LUNCH to follow / NATIONAL QUALIFIERS MEETING (read following page on National Qualifiers Meeting).

CONTESTANTS MUST BE FULLY DRESSED IN WESTERN ATTIRE AT ALL TIMES~ BEGINNING AT CHECK-IN AND MANDATORY CONTESTANTS MEETING, ROUGH STOCK SAFETY MEETING AND EQUIPMENT INSPECTION. (Contestant's Helper/Assistance allowance refer to NHSRA rule book.) NO ATTENDANCE, NO RODEO!!

1. Contestants, Rodeo Officials, Arena Crew, Stock Tenders, and Judges **MUST** be in Western Attire. Description of Western Attire: Long pants (Jeans), Western shirt – wrist length sleeves shirt with collar and cuffs. Shirts must be tucked into pants. Western Boots must be worn and sneaker type “sport shoes” are not acceptable footwear. No sweatshirts, T-shirts, or pullovers allowed. Western hat (cowboy hat). No ball caps or visors. NOTE: Secretary & staff **MUST** be dressed in Western attire (with the exception of the hat rule.)
2. Contestants **MUST** wear their back numbers on their backs and number must be visible at all times while competing in their events, when at rodeo or rodeo grounds or any rodeo function. It must be pinned or properly fasten on the back of the outer garment (shirt, vest, sweater, jacket *zip or button no pullovers). **NO OTHER LOCATION.** It must be worn upon entrance to rodeo grounds on performance days and during rodeo performances as well as fun night and awards banquet. Removal of number only upon exit of rodeo grounds or facilities. Rough stock contestants must pin or fasten their back numbers on the back of their safety vests for their event. **FULL** dress code upon entering rodeo grounds!
3. Rodeo Officials and Event Directors **MUST** Check-in on rodeo performance days with rodeo secretary.
4. **NO HORSES PERMITTED IN THE “GENERAL PUBLIC” AREAS** (i.e.: public parking area, spectator bleachers, concession stands). **THINK – SAFETY FIRST.**
5. **NO SALE OR CONSUMPTION OF ALCOHOL DURING A NHSRA SPONSORED RODEO OR ON RODEO GROUNDS. CONTESTANTS - NO USE OF TOBACCO PRODUCTS WHILE IN THE ARENA DURING ANY RODEO PERFORMANCE. NHSRA RULES WILL APPLY. RULES APPLY TO EVERYONE. READ YOUR HANDBOOK!**
6. Contestants are responsible for knowing the rules, especially the event rules. Know your “chain of command” if a discrepancy arise act quickly and respectfully.
7. Contestant disqualification rules will be strictly enforced. See NHSRA Rules By-Laws and Constitution handbook for details.
8. The decision of any judges, flagmen, or timers will be final and no protest by contestant will be permitted, except first through the contestant event director or a National Director and or Arena Director. See NHSRA Rules, By-Laws & Constitution handbook for details. Protest from any non-contestant will not be tolerated and will be grounds for disqualification of contestant. Non-contestants will not be allowed in arena at any time except for officials or helpers appointed by the Arena Director and or Rodeo Coordinator.
9. Jerk down rule will be strictly adhered to by the flag persons in the Tie-Down roping event.
10. Breakaway nylon string shall be tied directly to the saddle horn and a **WHITE** flag be affixed at the tail end of the rope. Refer to NHSRA rule handbook for details. Breakaway string will be provided.
11. Hat rule will be enforced by the barrier judge for the Goat Tying, Barrel Racing and Pole Bending events.
12. Three call rule will be enforced for all contestants. If after the third call is made and contestant is not ready to compete, he/she will be given a “no time” and drawn stock will be turned out. Other ground rules may be introduced and applied, if necessary, by Parker Ranch, HHSRA, and officials by the onset of the Rodeo weekend.
13. **Roughstock Safety Vests- All contestants must wear a vest designed to protect the chest and back while contesting in any roughstock event. The vest shall be one manufactured for rodeo/equestrian events and sold by retailers. This will be inspected at roughstock equipment inspection prior to rodeo.**

Note: NO horses allowed in the Parker Ranch Race Track

**MANDATORY MEETING FOR ALL NATIONAL QUALIFIERS, PARENTS &
OR GUARDIANS.**

Huron, South Dakota from June 23rd ~ June 29th, 2019

Decision to attend or not to attend the National Junior Rodeo Finals will need to be made at this meeting on Sunday May 12, 2019. ALL DECISIONS WILL BE ACCEPTED AS BEING FIRM. ONLY IN CASE OF AN EMERGENCY WILL YOUR ENTRY BECOME VOID. NO ADDITIONS OF EVENTS WILL BE ACCEPTED AFTER INITIAL ACCEPTANCE OF EVENTS QUALIFIED IN. ABSOLUTELY NO PAPER WORK WILL BE ALLOWED TO BE TAKEN HOME AND MAILED AT A LATER DATE. NO EXCEPTIONS.

BOTH parents (if applicable) and or Legal Guardian/s MUST BE PRESENT to notarize their child's entry if attending the NHSRA Junior Division Finals Rodeo, Huron, South Dakota. A notary will be present to notarize necessary forms for your participation in the National Finals Rodeo Junior Division. Please be sure to bring proper documentations for both the qualifier and parent/s (both if applicable) and or legal guardian/s. (Valid picture ID, Hawaii Driver's License or State ID. Birth certificate, for the minor, if no other valid form of ID is available).

This action is to eliminate wrong filings with the National office and to allow contestants in position's 5 through 8 a chance to participate in the Junior National Finals Rodeo. The deadlines are set by the National Office and must be adhered to by the State Secretary. NO EXTENSIONS ARE PERMITTED. Payment for housing, stalls, and jackpots will be collected.

Last years costs: Housing \$325; Stalls \$159 (studs \$185); Jackpot \$75 per event

Please be sure to schedule your flight home so that it will NOT interfere with your paperwork being completed for Nationals. NO paperwork will go home with you. All documents must be turned in to me on SUNDAY MAY 12th.

There will be NO EXCEPTIONS! I have a deadline to meet with Nationals and they have NO EXCEPTIONS.
